

**Agreement for Reciprocal Membership Privileges
Between The Union of Physicists in Bulgaria and The Physical Society of Taiwan**

The Union of Physicists in Bulgaria (hereafter, UPB) and the Physical Society of Taiwan (hereafter, TPS) and agree to enhance interactions among the members and extend reciprocal membership privileges as defined below.

1. Members of the UPB (TPS) may submit papers to the TPS (UPB) meetings with the same privileges and limitations as TPS (UPB) members;
2. Members of the UPB (TPS) may register at the TPS (UPB) meetings at member rates;
3. UPB and TPS agree to exchange relevant publications, such as the "Abstracts" (Program and Abstracts of the meetings of TPS), "Bimonthly Journal of Physics," and other physics journals managed by TPS such as the "Chinese Journal of Physics (CJP)," with available publications and materials produced by UPB. The specific materials for exchange may be updated periodically to best reflect each society's current resources;
4. Both societies agree to enhance information exchange on meetings, seminars, and workshops organized by either society;
5. Both societies agree to encourage bilateral visits by officers to directly exchange views and strengthen their relationship.

This agreement shall automatically renew unless either UPB or TPS submits written notice of its intent not to renew prior to the expiration of the current term.
